

ELECTION ORDER

THE STATE OF TEXAS

COUNTIES OF POTTER AND RANDALL

BE IT ORDERED, by the Board of Trustees of the Amarillo Independent School District, that an election be held in the School District, counties of Potter and Randall, on Saturday, May 6, 2023, for the purpose of electing three (3) members to the Board of School Trustees to be elected to fill four-year terms. Voting will be conducted using an electronic voting system.

All candidates for School Trustee shall be elected using the cumulative voting method.

All candidates who desire to have their names on the official ballot must file their declarations in writing with the Chief Financial Officer of the Amarillo Independent School District at the Education Support Center, Room 240, 7200 I-40 West, by 5 p.m. on Friday, February 17, 2023.

The Amarillo Independent School District shall contract with the respective election officers of Potter County and Randall County to conduct early voting, give notice of the election, prepare the official ballot, appoint election officials and persons to work in the Central Counting Station for ballots cast in the District election within each respective county.

The election day voting locations set forth in Exhibit "A" for said election are hereby declared. The voting locations for early voting are set forth in Exhibit "B". Because the District will contract with the respective counties for the conduct of the District's election, the Board of Trustees for the District hereby accepts and approves of any and all changes made by either County to the stated polling places or vote centers, subsequent to the passage of this Order, to the extent that such change(s) by a County is lawful and timely authorized in the manner provided by the Texas Election Code. Any such changes shall be reflected in the Notice of Election.



The returns of said election shall be made to the Board of Trustees of the Amarillo Independent School District in accordance with the election laws of Texas. A copy of this order, signed by the President and attested by the Secretary of this Board, shall serve as proper notice of said election, and the President shall cause notice of said election to be given in accordance with said laws.

Be it further ordered, pursuant to the authorization of Article 271.002 of the Election Code and Section 11.0581 of the Education Code that this election will be held jointly with the City of Amarillo and Amarillo College, for the election of the members of their governing body.
